## Dear Ms Ganslandt,

In accordance with Article 2 of Protocol 32 to the EEA Agreement, the Standing Committee of the EEA EFTA States shall communicate to the European Commission a list of European Union Programmes and activities which the EEA EFTA States wish to include in the EEA Annex to the preliminary draft budget of the European Union for the first time.

With reference to the European Commission Proposal for a Multiannual Financial Framework for the years 2021-2027, the European Commission's budget in 2021 is foreseen to include appropriations to several new EU Programmes of EEA Relevance.

These implications will need to be addressed under the budgetary planning of each EEA EFTA State over the course of this year. Consequently, a final decision on participation in individual Programmes can only be made at a later stage.
