## **Restoring a Volvo Truck**

Well, anyway, we had to make a list of the parts that were changed, check their cost price and produce a work schedule. Our teacher was quite strict about documentation.

**Jessica**: Well, the electronic components did not work properly, and we had to ask a workshop that specialized in heavy–duty transport vehicles to assist us. the bodywork, and the auto body painters gave it a specialised clear coat finish. Look, (*she shows them on her phone*) isn't she a beauty? And with a four-door crew cab, it's all you can ask for...

It says here: "Enter 'REGNR' (space) followed by the registration number of the vehicle you request information about, and send the message to 2282.
