2021 British Literature Exam

This exam consits of two parts. Make sure you answer both parts.

Part 1

Short Answer/Analysis (40%)

Answer **two** of the following questions. Answers should be 1-2 paragraphs (half a page to a page, 1.5 spaced, per question). Remember to use MLA in text references for any secondary material you use, as well as for the primary texts themselves. Include an MLA Works Cited at the end of this section. You MUST cite directly from the primary texts (e.g. novels, poems, or plays) that you discuss.

- 1. Victorian literature, Medieval Literature, Modernism, Renaissance Literature, Romantic literature
- Choose three of these terms and put them in the right historical order, provide very brief
 information about each period, and mention one text on the syllabus from each period.
 (Remember, if you use general information from your own memory you don't need to
 reference this. Unlike the other questions, this question does not require you to quote from
 the texts you mention, but you should still include them in your Works Cited.)
- 2. What is the role of the nightingale in Keats's "Ode to a Nightingale"?
- 3. Do you think *Othello* should still be studied? Why/why not? Remember to quote directly from the text as part of your answer.
- 4. How is nature depicted in Ghost Wall?

Part 2

Essay (60%)

Make sure your essay has an introduction (including a thesis statement), a body and a conclusion, uses MLA in text references, and has an MLA Works Cited. Do not repeat material from part one. There is no set length for the essay, but make sure it is a complete essay that makes an argument. Around five paragraphs, 2-3 pages, is ok, but it can be longer. Quality is more important than quantity. All sources that you quote or use ideas from MUST be cited. Quality sources such as the *Norton Anthology* are best. Articles from newspapers and library websites are ok. The most important thing is that you cite everything you use, to avoid plagiarism. As part of you answer, you MUST quote directly from the primary text (e.g. poem, novel or play) that you are discussing.

Answer one of the following questions:

- 1. How do the sensations and descriptions of warmth and cold provide structure and meaning to Charles Dickens' *A Christmas Carol*?
- 2. Many modernist texts contain 'epiphanies'. Write an essay that contains an argument about the role of (or the questioning of) the epiphany in one or more modernist texts on your syllabus (*Mrs Dalloway*, "The Garden Party" or "The Love Song of J. Alfred Prufrock"). While *Arcadia* is not strictly speaking a modernist text, you may also choose to write about *Arcadia*.
- 3. With reference to any poems on the syllabus, write an essay in which you explain how the form of the poem relates to its content. (You may choose to refer to more than one poem, but your essay must produce a convincing argument and structure, not be just a list of observations.)

SELF-DECLARATION

Examples of breaches of the provisions on cheating in connection with exams and other student work (coursework requirements etc.) include:

 same applies if the answer paper closely resembles another/other answer paper(s)
 or has clearly been written by others.
